5. Cautions

- a) Required by professional operators to use this device;

6. Operation

- 6.1 Check before use
- a. If the package is included of the IFU, the certificate of the product, and the product;
- b. If the package sealing is completed;
- c. Open the single pouch, if it is damaged or not. If any damaged, please don't use it and contact to Alton or local distributor to exchange immediately.
- 6.2 Operation
- a. Open the single pouch, and use it according to the IFU by operator;
- b. Select the model to according to different patients to avoid any harms for patients.

7. Sterilization/Cleaning

- a. The bite blocks are not sterilized by Alton in delivery;
- b. No need to be sterilized before use;
- c. Only for single use.

8. Validity period

Ten years for storage before opening the single bag.

9. Storage

- a. To be storage indoor and keep the environment clean and dry;
- b. The environment Temperature 0 °C -40 °C, Relative humidity 30-85%, and air pressure 50.0-106.0KPa;

c. Avoid direct sunlight.
